Notice Concerning Change in Business Segments

Startia Holdings, Inc. (the "Company") announces that at the meeting of its Board of Directors held today, it has decided to change its business segments, effective from the first quarter of the fiscal year ending March 31, 2026, as described below.

1. Overview and Reasons for the Change

The Company Group is reviewing its business segments with the aim of disclosing management information that accurately reflects its actual business activities.

Previously, the business efficiency solution business (including RPA [Robotic Process Automation] and iPaaS [Integration Platform as a Service]) developed by the consolidated subsidiary Startia Raise, Inc. was classified under the "IT Infrastructure-related Business" segment.

Meanwhile, the "Digital Marketing-related Business" developed by the consolidated subsidiary Cloud CIRCUS, Inc. is a business in the DX (Digital Transformation) domain, centered on marketing support.

As both businesses have a high affinity in that they support corporate business efficiency and digitalization, the Company has decided to integrate and reclassify them under the new name "DX Solution-related Business."

This change will more clearly reflect the business structure centered on DX promotion and enable the provision of management information that is more in line with the actual business conditions to investors and other stakeholders.

Please note that segment information for the first quarter of the previous fiscal year is presented based on the new segment classification.
